ON REACHING FORTY

This is not a personal revelation nor even the public announcement of the well kept secret of one of our young looking matrons or men. It is a bit of news which was passed on to us by Mr. Henry Hartnell, long time resident of our town, who tells us that this year Baie d'Urfe is forty years old. We do not know what purposes of convenience or necessity lay behind the incorporation of what must have been a very sparsely settled area, but here we are and still a-growing. Forty seems to be particularly significant, a sort of turning point for the individual and perhaps it is applicable to a town as well. We all know the popular saying that "life begins at forty". There are other observations which may carry a bit amusement for you, for instance this one written back in the eighteenth century: "At thirty man suspects himself a focl; knows it at forty and reforms his plans". Or this one of Oliver Wendell Holmes; "To be seventy years young is sometimes far more cheerful and hopeful than to be forty years old". Gertainly the recent and rapid growth of the town has meant the reforming of plans and created situations which require all the cheer and hope that can be brought to bear. It is a lively age suggesting a good balance between perspective and wisdom on the one hand and on the other the vitality to tackle the problems of the hour. Happy Birthday to You, Baie d'Urfe.

SCHOOL AFFAIRS

All appointments for the Central Board, effective for the next four Vears, have been completed by the various local boards. W.E. Butler, R.F. Angus and W. Spriggs will represent Baie d'Urfe-Senneville, J.T. Farmer will represent Ste Anne de Bellevue and Mr. G.C. Henderson, who has been appointed by the Vaudreuil-Dorion Board, will also represent Isle Perrot, Isle Cadieu and Belle Plage. W.E. Butler and W. Spriggs have been re-elected Chairmen of the Central and Baie d'Urfe-Senneville Boards respectively. Lt. Col. V.H. Graham has been re-appointed Secretary Treasurer of both the Central Board and our local Board.

Mr. Julien Meloche and Mr. Vivian Smith have been re-engaged to drive the Ste Marie and Lakeshore Road busses. The kindergarten class will continue to use the thion Church hall as before and an extra Grade III classroom has been provided and equipped at the rearof the main corridor on the ground floor of the school.

Arrangements for the New Extension are certainly moving along now.

Our loan has been approved by the Minicipal Commission and underwritten in its entirety by

A.E. Ames & Co. In spite of the most urgent representations by the Board, the Municipal

Commission were adamant in their refusal to allow us an interest rate of higher than 4%.

Consequently, due to existing and probable future conditions in the financial markets, we
have been compelled to accept a price of \$92.2h per 100 for the bonds, resulting in a loss
of available cash of over \$50,000. The yield on the bond issue to maturity will be 5.15%.

The increase in taxation to cover interest and repayment, based on the entire area under

Control of the Central Board, will be approximately 4 mills or an increase over the present

Tate of how.

As was explained in the last issue of News and Views, the recent increase in construction costs has made it necessary to modify the plans somewhat. It was finally decided to avoid any change in design by omitting eight rooms and two wash rooms from the top floor together with the cloak rooms and entrance foyer of the gymnasium.

This can all be added at a later date without affecting the rest of the building in any way.

At a special meeting of the Baie d'Urfe-Senneville Board on August 9th, the lowest tenders, based on the modified plans, were accepted from J.S. Hewson & Co. Ltd. for the general contract (\$636,192.) and from Thos. O'Connell Ltd. for the heating contract (\$82,564.) Both contracts were signed on August 17th. Hewson & Co. are at present building the new freight sheds and offices for the C.N.R. at the old Bonaventure Station in Montreal and have had considerable experience in school construction.

Difficulties have been experienced in obtaining reinforcing steel (102 tons). Our steel orders, placed in advance five months ago, have been cancelled due to National Defence Rulings by the Steel Controller and arrangements are now being made to obtain foreign steel at an increase in cost which will be additional to the general contract price. Our "Contingency" item is beginning to feel a bit weak!

The house which we had to dispose of has been sold to Lucien Raymond and is being moved further down Maple Avenue. Agreements have been signed with McGill Universit (Macdonald Buildings and Grounds Department) for the construction of a pole line and substation for power supply (\$5,494.) and also for the moving of a double garage and construction of a driveway, as per McGill Agreement (\$575).

The next few weeks should see things realy starting. How about the loan of a silver spade?

HORTICULTURAL SHOW

The Horticultural Society's annual show held on August 18th showed a further improvement in quality and numbers of exhibits over previous years. The Town Hall was practically filled with flowers and floral arrangements while the balcony was used for vegetables.

A total of 69 exhibitors showed 399 entries but it is interesting to note that 24 of the 69 exhibitors were children, about three times the number of children who took part last year. This growing interest on the children's part is most encouraging and it is hoped to have more classes for them next year.

The first meeting of the new council was held at the Town Hall on Tuesday, July 3rd with all members in attendance. Mr. J. Gelinas was sworn in as Mayor by J.W. Long, Secretary-Treasurer. The aldermen were then sworn in by the Mayor.

Roads - P. Smith, W.H. Parker Town Planning - D. Laird, G. Buch Finance - F. Dorion, D. Menzies

It was reported that the Forsythe excavation had been filled in by the town and charged to the property. Plans are well on the way for the making of the road in Sumny Acres and the repairing of Lekeview, Morgan and College Green roads. We may expect to hear soon from the council re chimney sweeping. Mr. A.W. Ware of Lakeview Rd. has been appointed Building Inspector. Due to the number of complaints from citizens, it was approved that signs be put up at the Town Hall forbidding dogs on the Town property. It was recommended that the association bring this to its members attention. For those who are interested, the main complaints were (1) dogs in the water (2) excessive barking (3) spoiling the flower beds (4) dirt on the lawn where citizens like to sit on a warm afternoon.
